Delivery Info: Before or by September 9th, from 10:00 am to 5:00 pm at Patchwork Quilt Shop, or Cloverleaf Hall September 10th, noon to 3:00 pm.

An identification label must be fastened securely to the bottom back right hand corner (as you look at the back). The label must contain the full name and address that appears on the entry form

Claim checks will be given at the time quilt is delivered. Claim checks will be required for quilt pick-up. No quilt will be released without one. **NO EXCEPTIONS.**

Pick-Up: Quilts will be picked-up Sunday, September 13th, between 4:00 pm and 5:00 pm at the Cloverleaf Hall.

Please note: Any exhibitor wanting a quilt returned by mail must provide postage, insurance and a mailing label.

Please don't enter quilts that have been entered in the HCMD Quilt Show within the past two years.
