Animals will be sold as registered ONLY if papers accompany the animal to the sale. No announcements will be made stating that “papers are available.” Any animal entering the sale ring without papers will be sold as “grade.”
2. **CHECK IN:** All animals must be tagged with a sale lot number on sale day. Animals must be checked in by 4:00 pm on Saturday September 11, 2010.  
If a specific number placement is requested, please ask for that number when pre-consigning your animal. Class and order of arrival will determine the sale order of animals not pre-consigned.
3. **MINIMUM BIDS** or “STOPS” will be taken seriously. If you place a stop price, your animal will not be sold if the minimum bid is not met in full. *No Sale* charge is \$50.00 plus applicable vet charges.
4. **SALE COMMISSION:** Sale commission is 7% on all animals or a minimum of \$50.00 per head, whichever is greater. *No Sale* charge is \$50.00 per head. No Sale charges must be paid before the animal is released. Applicable Vet Fees are in addition to commission charges.
5. **SALE ORDER:** Pre-consigned animals will be sold in the first section of this sale. Order of arrival will determine the sale order of animals not pre-consigned.  
Deadline for pre-consigning is August 20, 2010. No substitutions of catalogued animals.
6. **ANY ANIMAL FOR SALE DURING THE HCMD EVENT MUST BE SOLD THROUGH THE HCMD SALE. PLEASE HONOR THIS POLICY!**
7. **ALL ANIMALS WILL BE GUARANTEED SOUND BY THE SELLER UNLESS OTHERWISE INDICATED.**
